



This tract of ground was previously part of Hilltop Acres Subdivision as platted in Plat Vol. 4 Page 139. The deeds were written with legal descriptions which did not match the subdivision plat. When a survey was done, it was discovered the lines of occupation were different from the deeds and plat. The two owners elected to vacate the original subdivision plat (see OR 83-867 & Plat 18-39 & 18-40) and replace the original deed descriptions with new ones that reflected the lines of occupation.
