This parcel has a negative balance after exceptions, however, there is a parcel of land left which lies East of CR 50 in the SE cor of lot 3 which was not included in the new description for 25.37 ac. I believe this was to be included as it was part of the I.D. Cline farm and had been transferred to Mary Cline with the old descriptions on Deed 97/339. Later a new description was used to settle the I.D. Cline estate calling for 25.37 ac.

I believe it was the intent to transfer this parcel with the new description and is currently occupied by the owner of the 25.37 ac. in Lot 3 and the 23.50 ac tract in Lot 19 & 3, and the 14.63 ac tract in Lot 2. (which said 3 tracts completely surround the area in question.
