A 3.22 ac. tract was transferred from Katherine Kornis to Robert Kornis in 148-171. This parcel no longer exists as an individual, being now considered as part of the 49 ac. tract in the SW quarter of Sec. 16, later conveyed from Katherine to Robert in 177-772.

A 2.952 ac. severed residual parcel was given lot split approval when a larger split was recorded in DV 247-406 and Plat 13-107. This lot split approval was recorded in Plat 12-449 but a deed was not recorded with it.

The recorder assigned the same Plat vol 12-449 to another recorded document (see DV 247-480) in Section 31, T-15, R-12 Salt Creek Twp. Both plats are in the plat book.
