deed calls for outlot 6 ex. the piece to Susie Brenner and the piece to M.O. Meier. the 8.58 is retained by Myrtle Lake when she sells the balance to Ohio State Camp in 111-280. the deed calls for 12.29 ac after the exceptions, but there doesn't look like enough land is left to be 12.29 ac. unless it is meant to include the part of the lake in Ripley Twp.

The Board of Trustees of the Ohio District Council, Inc. of the Assemblies of God quit claimed a 0.071 ac tract (OR 139-509 and p. 2-358) to Yoder. This did not create a new parcel, it only cleared up an overlap situation.
