Hochstetler and Vesta Hochstetler in O.R. Vol. 161 Page 330, (PPN 0100036011), Eli J. Hochstetler and Vesta Hochstetler in Deed Vol. 237 Page 730, (PPN 0100214000), and part of the lands of Holmes Ingram Group, Ltd. in O.R. Vol. 225 Page 1144, (PPN 0100315000).

Commencing at 5/8 inch rebar found marking southwest corner of the northeast quarter of section 15, thence S 85 degrees 13'53" E a distance of 890.75 feet along the quarter section line to a point in State Route 39, thence S 29 degrees 40'23"E a distance of 9.81 feet along the east line of William Jr. Yoder and Mary A.
