- 3) N 00 degrees 53' 37" W 100.00 feet through the lands of said Miller to an iron pin set on the section line:

4) N 88 degrees 59' 14" E 165.53 feet along the section line to the TRUE POINT OF BEGINNING.


The above described easement shall include additional portions of the Grantor's property reasonably necessary for the construction, installation, operation, maintenance, repair and/or replacement of the septic system.
