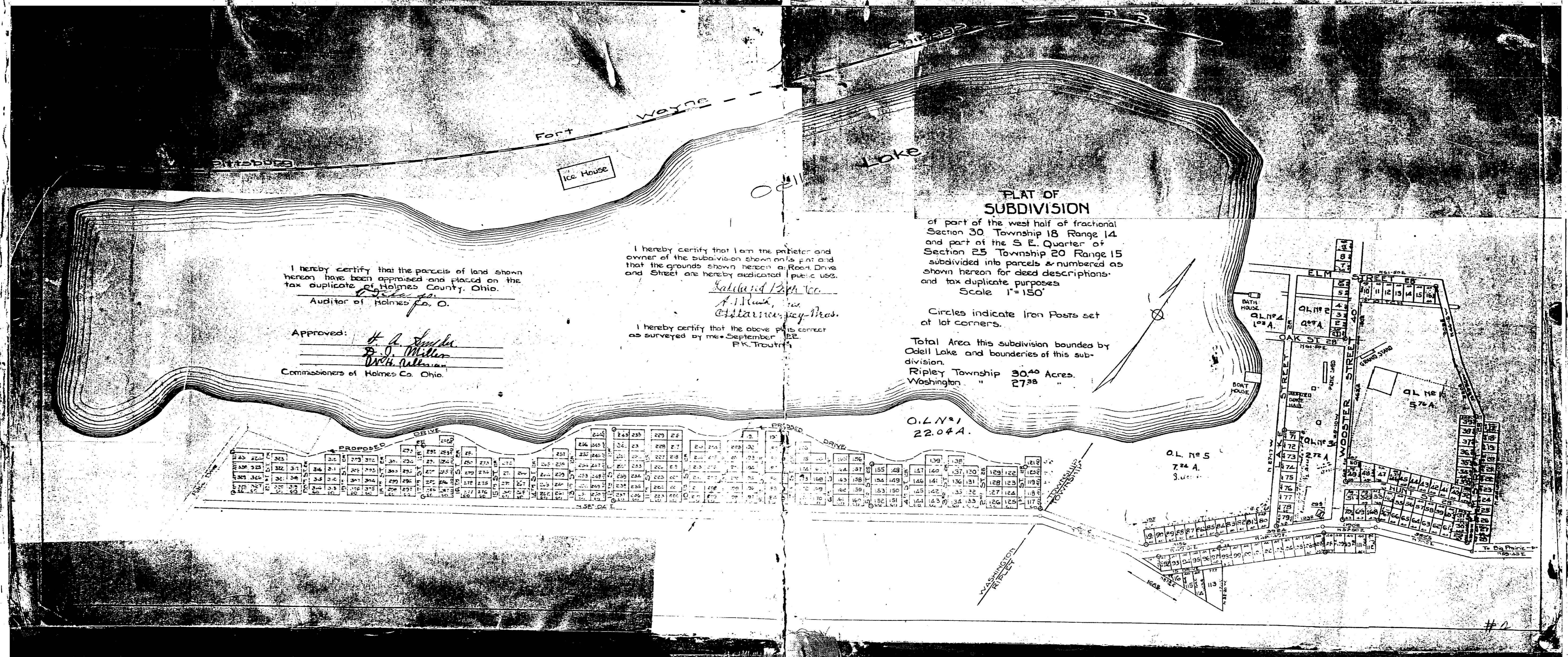


PLAT OF LAKELAND BEACH CO.

To the Commissioners, Auditor and Surveyor of Holmes County, Ohio: We, A. V. Rush, President and C. S. Stainer, Secy. - Treasurer of The Lakeland Beach Company, of Big Prairie, Ohio, hereby request that the following changes be made in the Plat of the Lakeland Beach Company, Holmes County, Ohio:

- 1- That lots - lots Number 71 to 79, inclusive be thrown into Cut Lot No. 3.
- 2- That lots - lots Number 80 to 91, inclusive be thrown into Cut Lot No. 5.
- 3- That the drive 15 feet wide, be vacated from South of County Road to lot No. 91.
- 4- That the balance of land shown on blue print in Washington Township, Ohio, from an Iron stake at the S. W. corner of lot No. 121, taken north to Odell Lake, then west to end of allotment in Washington Township, then portion being balance of survey in Washington Township, not included in lot No. 121, not shown on blue print as to number of acres it contained as we ask that same be shown as Cut lot with the number of acres contained therein.
