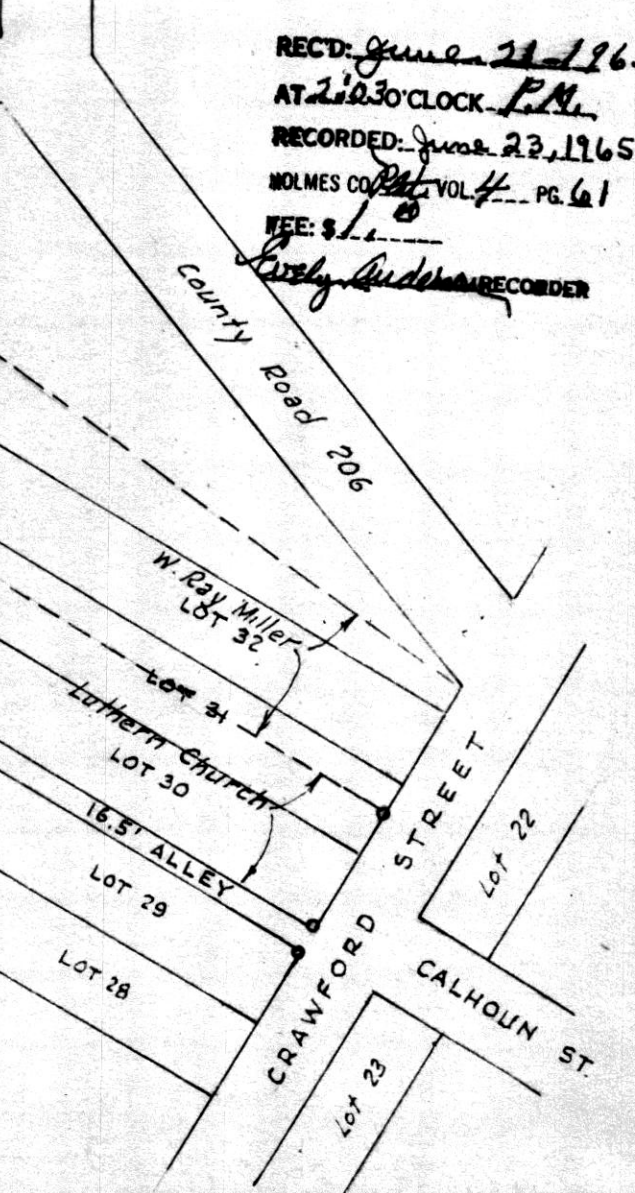
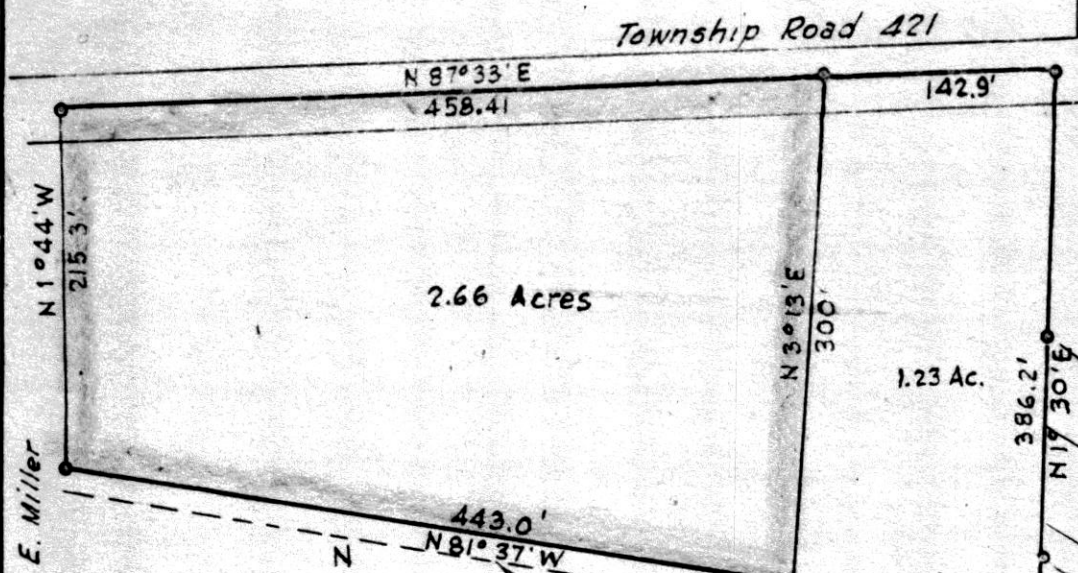

PROPERTY

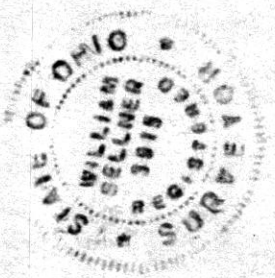

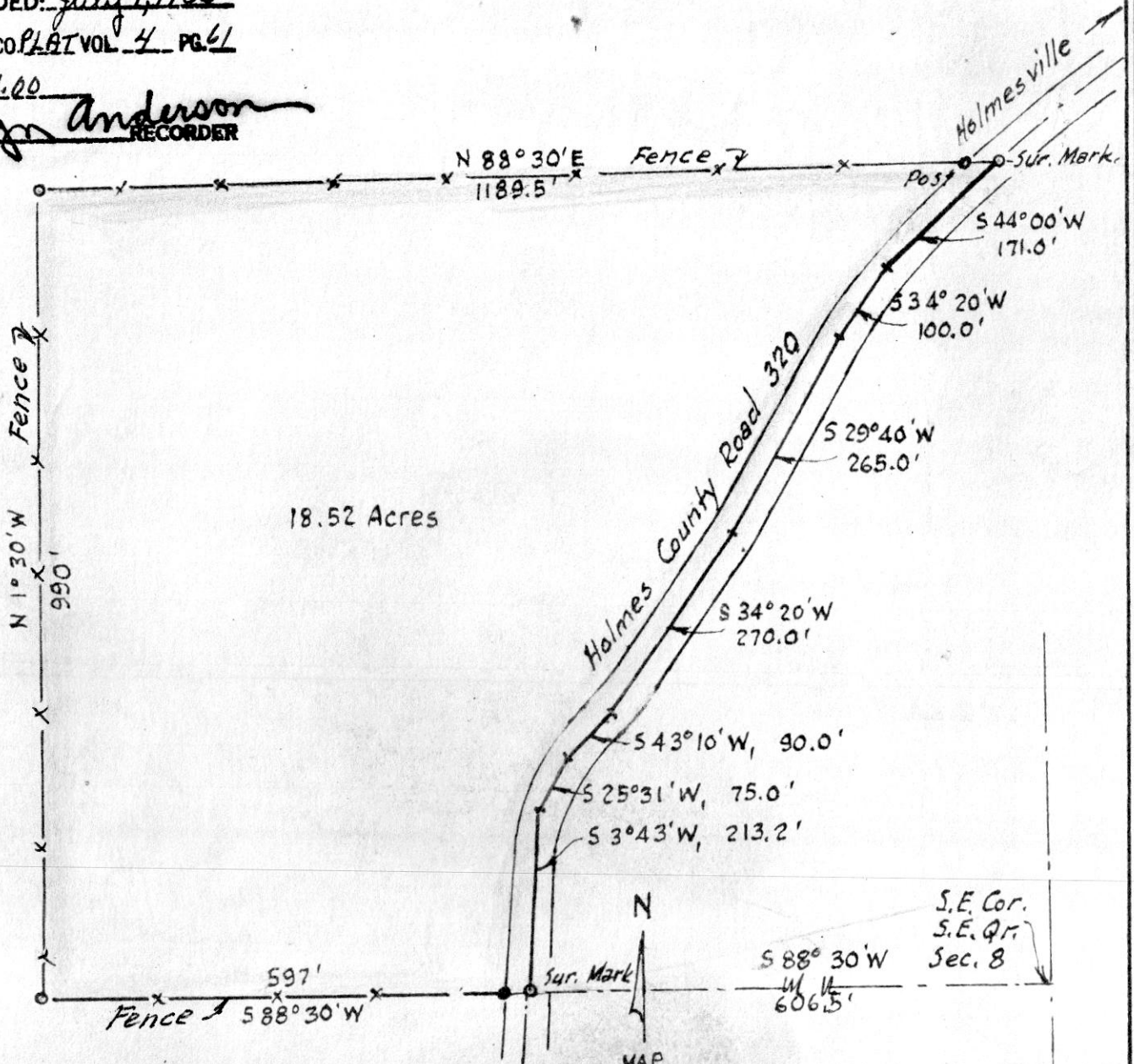

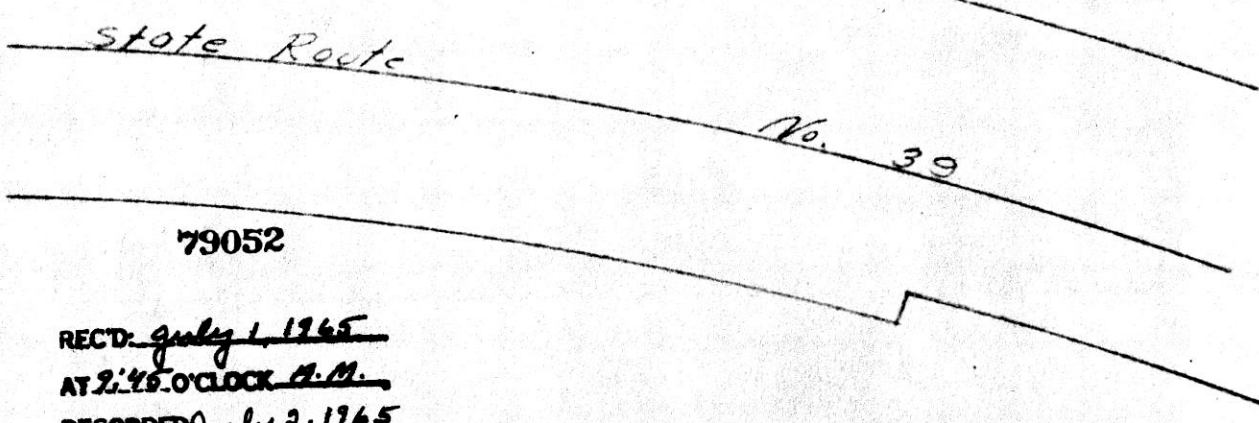
