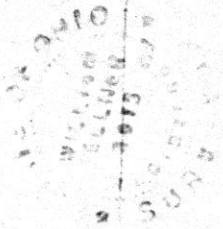

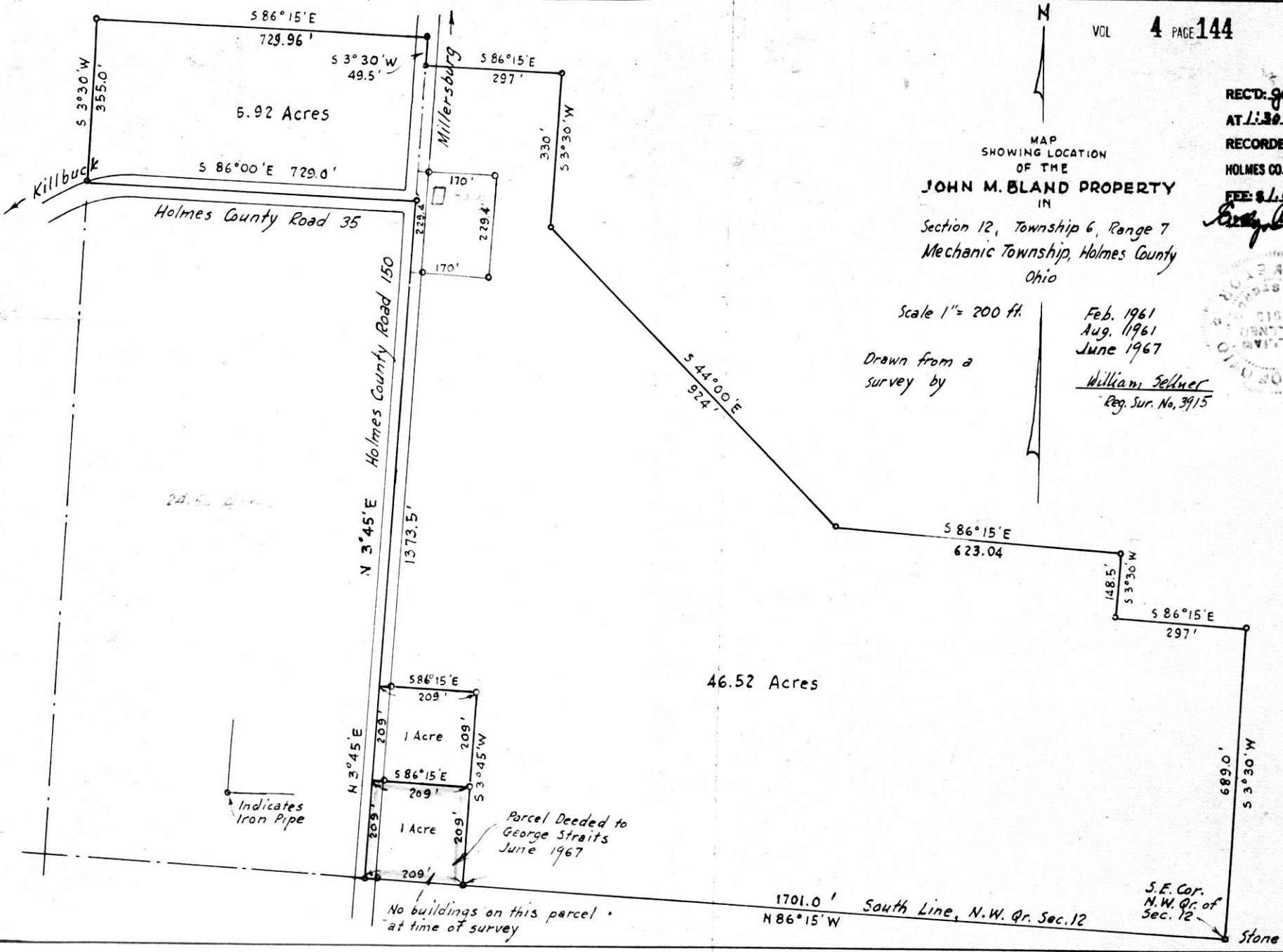

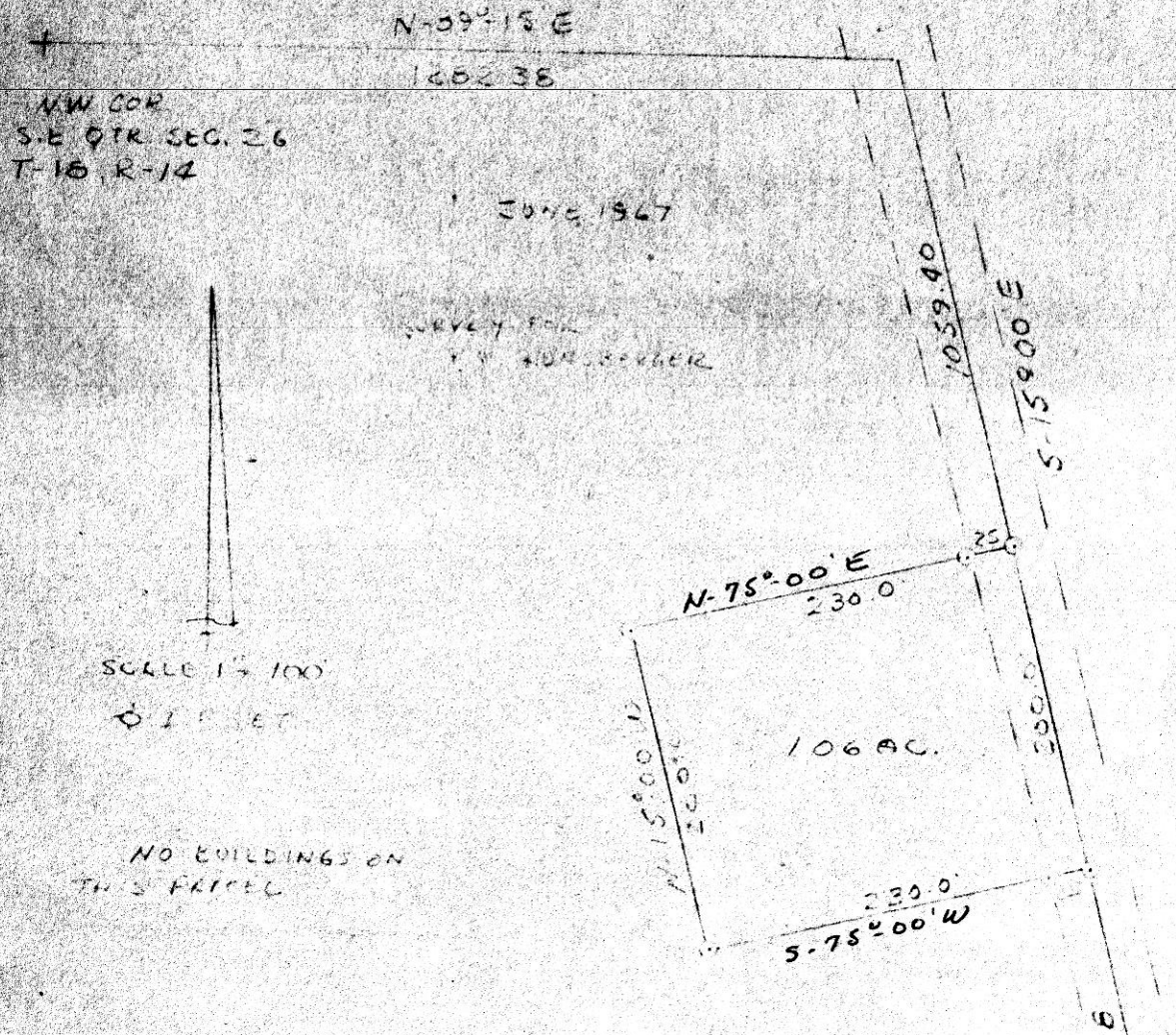


Graphic Scale in Feet
