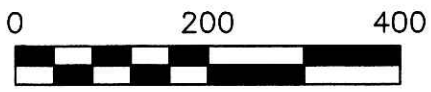

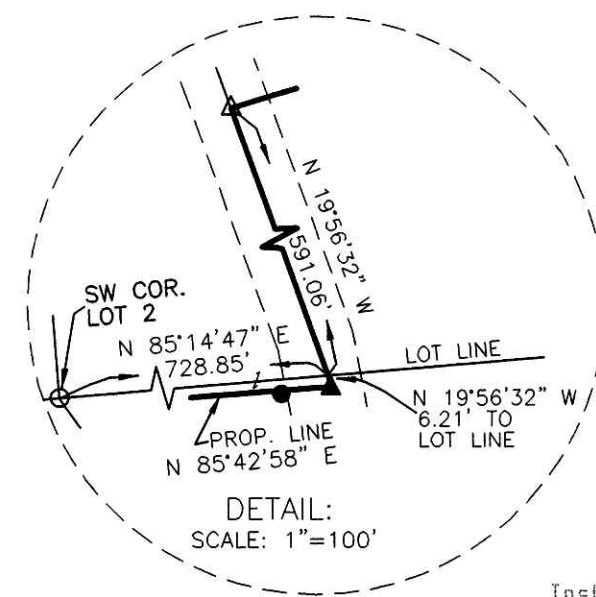

BECAUSE THESE PARCELS WERE PART OF THE SAME ORIGINAL FARM AND THE RIGHT EXISTED TO GRANT TO THE MONUMENTS ORIGINALLY SET, I HELD THE MONUMENTS FOUND.
