

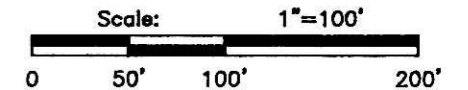
MAP OF SURVEY FOR RODRICK S. & BERNICE I. SHEPLER
