PROPOSED ANNEXATION TERRITORY  
VILLAGE OF KILLBUCK, OHIO

Being a part of the southwest quarter of Section 6, Killbuck Township, T-8 N, R-7 W, Holmes County, Ohio and described as follows:

Commencing at a point at the northeast corner of Lot 135, thence S 67 degrees 00' 00" E 15.20 feet along the corporation line to a point the TRUE POINT OF BEGINNING.

Thence with the following FOUR (4) COURSES:

- 1) N 67 degrees 00' 00" W 140.49 feet along the north line of Lot 135 and along the south line of a 12 foot alley and along the corporation line to a point on Rice-Chadwick Rubber Company AKA Alco Industries, Inc.'s (Deed vol. 225 page 558) east line;
- 2) N 10 degrees 30' 00" E 162.29 feet along said Rice-Chadwick's east line and along the west line of a 20 foot street and along the corporation line to a point;
- 3) S 67 degrees 00' 00" E 140.49 feet along the south line of an alley to a point on the west line of a 33 foot street and on the corporation line;
- 4) S 10 degrees 30' 00" W 162.29 feet along the west line of a 33 foot street and along the corporation line to the TRUE POINT OF BEGINNING.

This parcel contains 0.511 acres, Royce W. & Patsy J. Mullet (Deed vol. 252 page 819 & 822) owning 0.403 acres calc. (0.400 acres deed), and 0.108 acres in a 20 foot street and a 12 foot alley.

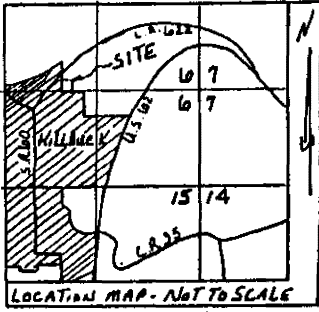

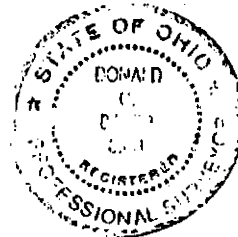
