The Holmes County Commissioners met in regular session Thursday, December 16, 2010; with everyone present. Chairman Miller opened the meeting:

8:30 A.M. – CHRIS YOUNG – ENGINEER – STANDING APPOINTMENT

Engineer Chris Young met with the Commissioners and discussed the Keim Lumber WWTP that Keim Lumber owns. Young informed the Commissioners that the Ohio EPA is currently giving Keim Lumber problems for their sewer treatment plant. Young stated that we would need serious grants to put in a Wastewater Treatment Plant for Charm. We could not afford to do it on our own. Young may go and speak with Keim Lumber and possibly with Richard Guggisberg who is expanding Guggisberg Cheese outside of Charm to see what they have in mind for their sewer plants. Guggisberg also has his own WWTP.

<u>ARNIE OLIVER – PLANNING COMMISSION – PLANNING COMMISSION BOARD</u> <u>DISCUSSION</u>

Arnie Oliver of the Planning Commission met with the Commissioners and discussed the Planning Commission Members that their terms end at the end December 31, 2010. The members that will be reappointed are Dan Schlabach and Jerry Schlabach for a three year term. There is an open position at this time and Oliver would like any suggestions from the Commissioners to fill that position.
