THE MINUTES

March 02, 2009

The Holmes County Commissioners met in regular session Monday, March 02, 2009, with all members present. Chairman Miller opened the meeting:

CHRISTINE FERENBAUGH - JAIL KITCHEN - UPDATE DISCUSSION

Christine Ferenbaugh of the Jail Kitchen met with the Commissioners to update them on how the Jail Kitchen is doing financially.

REAGAN TETREAULT - DOG WARDEN - PITBULL POLICY DISCUSSION

Dog Warden Reagan Tetreault met with the Commissioners to discuss the Dog Pounds Pitbull Adoption Policy. The Dog Wardens Office has picked up 10 Pitbulls so far for 2009. The State of Ohio considers the Pitbull a vicious dog. Tetreault explained to the Commissioners that she has picked up several on County line road, between Holmes and Wayne Counties. The City of Wooster does not allow pit bulls in the City. Tetreault has put together an adoption policy for the pit bulls. The pit bulls would be adopted out to a rescue located in Columbus. Tetreault would like to know who she would have to talk to in the County concerning her policy for the pit bulls. The Commissioners informed her that she would have to talk with the Villages and see if they would adopt an ordinance and possible talk with the Township Trustees. The current policy for pit bulls is that no pit-bull leaves Holmes County. Miller does not see a problem if the pit bull goes to a shelter. Eyler will be talking with Kevin Brooks the Village Administrator for Millersburg and the Commissioners will talk with the Township Trustees to see how they feel about the policy.
