THE MINUTES April 18, 2011

The Holmes County Commissioners met in regular session Monday, April 18, 2011; with everyone present. Chairman Miller opened the meeting:

ED BRITT – SOLID WASTE – GENERATION FEE DISCUSSION

Ed Britt of the Solid Waste Department met with the Commissioner and updated them on the first quarter of the generation fees collected in 2011. Britt informed the Commissioners that we have collected \$63,980.70 in generation fees for the first quarter of 2011. In 2010 at this time we had only collected \$46,500.00 in generation fees for the first quarter.

JACKIE McKEE – AUDITOR – ESTIMATED REVENUE REVISIT UPDATE DISCUSSION

Auditor Jackie McKee met with the Commissioners to update them on the estimated revenue revisited for 2011. McKee informed the Commissioners that starting August 01, 2011 there will be a 25% reduction in government funds received.

The next issue McKee discussed was the personal property tax that will be phased out. She informed the Commissioners that this will costs the General Fund \$500,000.00.

Next, McKee discussed the sales tax. McKee stated that the sales tax continues to be strong. The actual revenue receipts from sales tax are up by \$230,500.00 in 2011compared to in 2010.

McKee also informed the Commissioners that the years to date expenditures are up in 2011 compared to 2010.
