THE MINUTES January 21, 2010

The Holmes County Commissioners met in regular session Thursday, January 21, 2010; with everyone present Chairman Miller opened the meeting:

8:30 A.M. - CHRIS YOUNG - ENGINEER - STANDING APPOINTMENT

Engineer Chris Young met with the Commissioners to update them on the Wastewater Plants throughout the County. Young is looking in to having the sewer payments automatically deducted from their checking accounts for their sewer bills. Young believes that approximately half the people would sign up to have their sewer bills automatically deducted from their accounts. Young will send out a letter to the customer to have them sign up for the automatic deduction if they choose to do so. Young is working with the Commercial and Savings Bank to get the process moving forward.

Young also discussed paying off the smaller wastewater debts and then he will only have the Walnut Creek and Berlin debt left.

Young informed the Commissioners that there are currently two copper violations at the Berlin Wastewater Treatment Plant. Young is uncertain at this time were the copper is coming from. Young will do testing and try to isolate the situation. The copper is just a few milligrams over the legal amount.

Young is going to fix the fence at the October Hills Sewer Plant instead of replacing it at this time. The property owners have till the beginning of February to move their buildings/items off the right of way of the sewer plant.

Young is also switching task around in the Wastewater Department.

Young also will be putting together a list of County Roads to be paved in 2010 for the Commissioners.

ERIC McDOWELL & BRENDA RAMSIER - HELIPAD DISCUSSION

Eric McDowell of Huntington Insurance and Human Resource Director Brenda Ramsier met with the Commissioners to discuss the premium for the Insurance for the Helipad for Pomerene Hospital at the Fairgrounds. McDowell informed the Commissioners that the policy is for \$3,000.00. Lifeflight is a service that Pomerene Hospital provides to its customers. The Helipad is not covered under CoRSA Insurance due to the fact that it deals with aviation. Since it is aviation it has to go through and aviation insurance company. McDowell would just like guidance as to who should sign for the policy and who to send the invoice too. McDowell will leave a copy of the proposal for the Helipad Insurance and if the Commissioners have any questions please give him a call. McDowell stated that there are approximately 30 times a year that Lifeflight lands at the fairgrounds. No decision was made at this time.
