Tetreault also presented the Board with her 2009 year end report. Tetreault is pleased with the amount of dogs that were euthanized for 2009. The amount of dogs euthanized went down from 169 to 72 dogs. They also had a 84% adoption rate and the number of dog bites went down in 2009.

# NORTON ENVIRONMENTAL - LANDFILL DISCUSSION

Norton Environmental and Ed Britt of Holmes County Solid Waste met with the Commissioners and discussed the Holmes County Landfill. Miller informed Norton that if the expansion gets done, there will be plenty of room tonnage at the landfill. Norton does not want to come and take financial liability of the landfill. When Norton gets finished with all the testing and engineering they will come back to the Board and let them know if they are interested or not in running the landfill. If the possibility arises that that they can move forward with the landfill, they could start operating the next day. If they get 2  $\frac{1}{2}$  million cubic yards of the landfill, the County will not be responsible for any financial assurance for the landfill. If the amount is less than 2  $\frac{1}{2}$  million cubic yards, then the County would assume a portion of the financial assurance.

Norton needs the landfill to be a ten year facility and they need to be competitive. Norton is charging the same amount for garbage today, that they were charging 20 years ago due to the competiveness.

Miller informed Norton that we have to take bid/proposals for the landfill. Norton suggested that the County move forward with the bid/proposal process and that their proposal would be similar to what has already been given to the Commissioners.

The Commissioners would also limit the trash coming in to the landfill to just Ohio trash. Norton agreed with that also. The Commissioners would also like to have all the trash picked up in Holmes County to be taken to the Holmes County landfill. Norton stated that that would be helpful.

Miller would like to know that there is currently no line under the present landfill and if there is a possibility that it could contaminate nearby water wells. Norton believes that if it has not done so already that the chances are minimal that it would.

Norton would like to get up close and personal with the County landfill and they would like to see the County move forward with the bid/proposal process.

The decision was made to bring in Prosecutor Steve Knowling at a later date and discuss the bid/proposal process with him.

## **ADJOURN MOTION**

With no further business to come before the Board, Mr. Eyler moved that the meeting be adjourned at 4:30 p.m. Mr. Miller seconded the motion (Mr. Miller- yes; Mr. Eyler- yes; Mr. Ault - yes). The next scheduled Business meeting of the Holmes County Commissioners is Thursday, January 21, 2010 (Due to the Martin Luther King Jr. Holiday).
