#### March 22, 2010

The Holmes County Commissioners met in regular session Monday, March 22, 2010, with everyone present. Chairman Miller opened the meeting:

## JACK KERRIGAN, DON BREECE AND KIETH SMITH - OSU EXTENSION - DISCUSSION

Jack Kerrigan, Don Breece and Keith Smith of OSU Extension, Kate Schumacher and Chris Seiverdes of Holmes County OSU Extension met with the Commissioners to see if there could potentially be any funding for a full time/part time Ag Agent. Smith would like to know if it is a possibility to leverage funds to have Dr. Gary Graham who currently works out of the Wooster OSU Extension Office to come and possibly work full or part time at the Holmes County OSU Extension Office. Currently Holmes County does not have an Ag Agent and has to refer their phone calls elsewhere. If the County decides to go part time it would costs the County \$19,100.00 a year and the State OSU Extension would fund the rest.

Breece stated that Graham is a Holmes County resident and has experience working with the Amish. Miller informed everyone that currently there are many unknowns financially for the County.

Schumacher stated that the funding for OSU Extension is 25% of what it was four years ago.

Miller also stated that funding priorities over the last six years have changed but we do understand the importance of an Ag Educator for Holmes County.

The decision was made to discuss the situation and let them know at a later date. Smith would like to know within the next couple of months if at all possible.
