<u>MIKE SOMMERS, MIKE McDOWELL, CRAIG MILLER AND BRENDA RAMSIER –</u> <u>WELLNESS DISCUSSION</u>

Mike Sommers of Hummel Insurance Agency, Mike McDowell of Huntington Insurance, Craig Miller of Pomerene Hospital, Human Resource Director Brenda Ramsier and several Elected Officials and Department Heads met with the Commissioners and discussed the Wellness Program that Pomerene Hospital has initiated.

Craig Miller discussed this earlier this year with the Commissioners what Pomerene Hospital has initiated and Craig Miller is now going to explain their Wellness Program to the Elected Officials and Department Heads.

Pomerene Hospital charges a surcharge of \$20.00 a month if their employees smoke or use tobacco products and if the employees spouse has insurance through their employer then the spouse must go one their employers insurance. Pomerene has saved 12% on their premiums on just having the spouses go on their employers insurance. This is a one time savings but you must do wellness to help keep the premium costs down. Also, you cannot put a smokers surcharge on unless you have a Wellness Program in place.

There are four components to Pomerene's Wellness Program:

- 1. Health Assessment
- 2. Health Improvement
- 3. Preventative Testing
- 4. Smoking Status/Surcharge

Several questions were asked by the elected Officials and department Heads.

The Commissioners would like to meet again with the Elected Officials and Department Heads in three weeks after they have discussed this with their employees.
