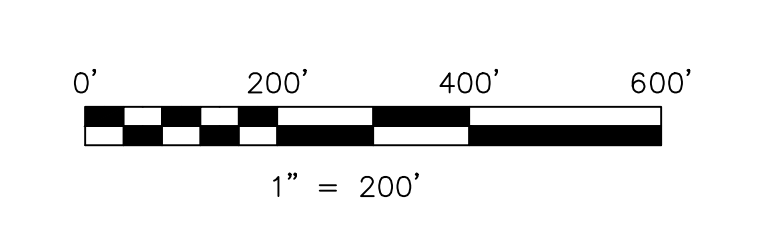


OVERLAP
This corner is covered by both DV 198-783 and original deeds to Lakeland Beach. A 2003 survey recorded in Plat Book 2 Pg 359 includes this within Outlot 5.

NOTE:
Exceptions on deed to the south (DV 197-810) are the southerly line, however the deeds on the north do not have the same dimensions, leaving a gap. SEE SR 4-332 for a plat which shows the exception parcels.
