Vol. 189 Page 490) and along S.R. 39 to a point, thence N 54 degrees 12'48" W a distance of 247.54 feet along the south line of said Troyer Land Ltd. and along said road to a point being the TRUE PLACE OF BEGINNING;

Thence with the following FIVE (5) COURSES;

- 1. S 47 degrees 56'54" W a distance of 412.37 feet along the west lines of David N. Troyer and Erma Troyer (O.R. Vol. 256 Page 1418) and Christian Aid Ministries (O.R. Vol. 91 Page 152 and O.R. Vol. 233 Page 1299) to a point and passing over a 5/8 inch rebar found at a distance of 46.77 feet;
