Miller and Esther M. Miller (O.R. Vol. 215 Page 1383), and Norman A. Hershberger and Cindy J. Hershberger (O.R. Vol. 234 Page 2865) to a mag nail set in said road and on the south line of said lot 1 witnessed by a 5/8 inch rebar found capped "Baker" N 33 degrees 12'37" E a distance of 32.50 feet;
- 6. N 88 degrees 19'19" W a distance of 214.73 feet along said road and the south line of said lot 1 to the TRUE PLACE OF BEGINNING;
