Yoder, co-trustee and Naomi H. Yoder, co-trustee (O.R. Vol. 280 Page 3894) and Marion J. Troyer and Saloma Troyer (O.R. Vol. 280 Page 7159) to a 5/8 inch rebar found, thence **N 04 degrees 19'07" E a distance of 125.00 feet** along the east line of said Marion J. Troyer and Saloma Troyer to a point being the TRUE PLACE OF BEGINNING.

- 1. N 04 degrees 19'07" E a distance of 20.00 feet along the east line of said Marion J. Troyer and Saloma Troyer to a 5/8 inch rebar found capped "Baker";
- 2. N 08 degrees 05'12" E a distance of 224.19 feet along the east line of Jonathan R. Yoder, co-trustee and Naomi H. Yoder, co-trustee (O.R. Vol. 280 Page 3894) to a point in the centerline of Township Road 367 witnessed by a 5/8 inch rebar found capped "Baker" S 08 degrees 05'12" W a distance of 12.58 feet;
- 3. N 77 degrees 18'31" E a distance of 49.99 feet through the lands of said Andy M. Miller and Martha Miller and along the centerline of said road to a point in the intersection of said road and Township Road 368;



- **4. S 65 degrees 28'13'' E a distance of 54.05 feet** through the lands of said Andy M. Miller and Martha Miller and along the centerline of Township Road 368 to a point;
- 5. S 67 degrees 52'22'' E a distance of 146.36 feet through the lands of said Andy M. Miller and Martha Miller and along the centerline of said road to a point;
- 6. S 10 degrees 55'34" W a distance of 225.64 feet through the lands of said Andy M. Miller and Martha Miller to a point passing over an iron pin set at a distance of 18.24 feet and witnessed by an iron pin set N 05 degrees 05'03" W a distance of 4.72 feet;
- 7. N 78 degrees 19'33" W a distance of 228.52 feet along the north line of Susie Yoder (Deed Vol. 223 Page 436, Deed Vol. 241 Page 459) to the TRUE PLACE OF BEGINNING.
