Being part of Lot 29 of the Third Quarter, Berlin Township, T-9 N, R-5 W, Holmes County, Ohio, also known as part of the lands of Andy M. Miller and Martha Miller in O.R. Vol. 177 Page 1133 (PPN 0100309000).

Further described as follows;

Commencing at a 5/8 inch rebar found marking the southwest corner of Lot 29, thence **S 88 degrees 59'04" E a distance of 571.44 feet** along the Lot Line to a 5/8 inch rebar found, thence **N 00 degrees 52'38" E a distance of 499.36 feet** along the east lines of Lot 2 of Stony Hill Subdivision (Plat Vol. 19 Page 4928) of Dennis R. Yoder and Esther R. Yoder (O.R. Vol. 284 Page 4067) and Marion J. Troyer and Saloma Troyer (O.R. Vol. 280 Page 7159) to a 5/8 inch rebar found, thence **N 00 degrees 54'52" E a distance of 580.05 feet** along the east line of said Marion J. Troyer and Saloma Troyer to a 5/8 inch rebar found, thence **S 87 degrees 41'23" E a distance of 67.01 feet** along the north line of E&N Land Holdings, LLC (O.R. Vol. 282 Page 4225) to a point witnessed by an iron pin set **N 10 degrees 55'34" E** a distance of 7.90 feet, thence **N 10 degrees 55'34" E a distance of 88.74 feet** through the lands of said E&N Land Holdings, LLC to a point witnessed by a 5/8 inch rebar found **N 04 degrees 59'13" W** at a distance of 4.73 feet being the TRUE PLACE OF BEGINNING.

Thence with the following **FOUR (4) COURSES;**

1. **N 10 degrees 55'34" E a distance of 225.64 feet** along the east line of E&N Land Holdings, LLC (O.R. Vol. 282 Page 6028) to a point in Township Road 368 witnessed by a 5/8 inch rebar found capped "Galbraith" **S 10 degrees 55'34" W** at a distance of 18.24 feet;
2. **S 67 degrees 52'22" E a distance of 50.97 feet** along the centerline of said road and through the lands of said Andy M. Miller and Martha Miller to a point witnessed by an iron pin set **S 10 degrees 55'34" W** at a distance of 18.36 feet;
3. **S 10 degrees 55'34" W a distance of 216.39 feet** through the lands of said Andy M. Miller and Martha Miller to a point witnessed by an iron pin set **N 10 degrees 55'34" E** at a distance of 3.67 feet;
4. **N 78 degrees 19'33" W a distance of 50.00 feet** along the north line of said E&N Land Holdings, LLC (O.R. Vol. 282 Page 4225) to the TRUE PLACE OF BEGINNING.
