- 6) N 60 degrees 09' 44" W 96.50 feet along the centerline of T.R. 362 to a point, witnessed by an iron pin set N 47 degrees 49' 54" E 27.60 feet;
- 7) N 47 degrees 49' 54" E 493.42 feet through the lands of said Dennis A. Miller and Ellen E. Miller to the TRUE POINT OF BEGINNING.
