16) N 00 degrees $33^{\prime} 32^{\prime \prime}$ E 561.85 feet along Julie Webb and William Webb's (O.R. 199 page 2255) east line to a $5 / 8$ inch rebar found in the center of T.R. 331, witnessed by a $5 / 8$ inch rebar found $S 00$ degrees $33^{\prime} 32^{\prime \prime}$ W 14.25 feet;
