Being part of the Northeast Quarter of Section 4, Berlin Township, T-9 N, R-5 W, Holmes County, Ohio, also known as part of the lands of Wayne E. Miller and Iva D. Miller in O.R. Vol. 284 Page 1073, (PPN 0100498000).

Further described as follows;

Commencing at a railroad spike found marking the southeast corner of the northeast quarter of section 4, thence N 88 degrees 52'47" W a distance of 375.95 feet along the quarter section line and T.R. 414 to a point, thence N 01 degree 33'16" E a distance of 263.85 feet along the west line of Daniel E. Miller and Esther Miller (O.R. Vol. 154 Page 213) to a 5/8 inch rebar found capped "Baker" and passing over a 5/8 inch rebar found capped "Baker" at a distance of 10.61 feet, thence N 56 degrees 38'22"E a distance of 96.62 feet along the north line of said Daniel E. Miller and Esther Miller to a 5/8 inch rebar found capped "Baker" being TRUE PLACE OF BEGINNING.

Thence with the following FIVE (5) COURSES;

- 1. N 56 degrees 38'22" E a distance of 29.17 feet through the lands of said Wayne E. Miller and Iva D. Miller to an iron pin set;
- 2. S 62 degrees 25'09" E a distance of 303.72 feet through the lands of said Wayne E. Miller and Iva D. Miller to a point on the Walnut Creek Township line;
- 3. S 01 degree 35'25" W a distance of 27.44 feet along the Walnut Creek Township line to point;
- 4. N 64 degrees 23'55" W a distance of 174.17 feet along the north line of said Daniel E. Miller and Esther Miller to a point;
- **5.** N 60 degrees 30'47" W a distance of 155.93 feet along the north line of said Daniel E. Miller and Esther Miller to the TRUE PLACE OF BEGINNING.
