Beginning at a $5 / 8^{\prime \prime}$ iron pin found at the southwest corner of said Northwest Quarter of Section 17; Thence S $88^{\circ} 18^{\prime} 49^{\prime \prime}$ E, along the southerly line of said Northwest Quarter of Section 17, passing a $5 / 8^{\prime \prime}$ iron pin found at a distance of 34.96 feet, a total distance of 787.97 feet to an iron pin set, said point being the True Place of Beginning for the parcel of land herein described;

Course No. 3; Thence S $29^{\circ} 13^{\prime} 59^{\prime \prime}$ E, along a southwesterly line of a parcel conveyed to Timothy P. Troyer and Shawna M. Troyer and recorded in O.R. Vol. 280, Pg. 1714 of the Holmes County Official Records, passing a bent $5 / 8^{\prime \prime}$ iron pin found at a distance of 177.30 feet, a total distance of 227.28 feet to a point;

Course No. 4; Thence S $67^{\circ} 33^{\prime} 00^{\prime \prime}$ W, along a northwesterly line of a parcel conveyed to Countryside Chapel of Baltic, Ohio and recorded in Deed Volume 277, Page 187 of the Holmes County Deed Records and along a northwesterly line of a parcel conveyed to Miriam Hershberger, Marvin Ray Hershberger and Anna Jean Hershberger and recorded in O.R. Volume 275, Page 6522; O.R. Volume 232, Page 1068; O.R. Volume 228, Page 1950 of the Holmes County Official Records and being a centerline of State Route 93 (variable width right-of-way), a distance of 97.00 feet to a point;

Course No. 5; Thence S $66^{\circ} 48^{\prime} 39^{\prime \prime}$ W, along a northwesterly line of said parcel conveyed to Miriam Hershberger, Marvin Ray Hershberger and Anna Jean Hershberger and being a centerline of said State Route 93, a distance of 64.47 feet to a point;

Course No. 6; Thence $\mathrm{S} 66^{\circ} 01^{\prime} 13^{\prime \prime} \mathrm{W}$, along a northwesterly line of said parcel conveyed to Miriam Hershberger, Marvin Ray Hershberger and Anna Jean Hershberger and being a centerline of said State Route 93, a distance of 134.81 feet to a point;

Course No. 7; Thence S $64^{\circ} 23^{\prime} 05^{\prime \prime} \mathrm{W}$, along a northwesterly line of said parcel conveyed to Miriam Hershberger, Marvin Ray Hershberger and Anna Jean Hershberger and along a northwesterly line of said
parcel conveyed to Countryside Chapel of Baltic, Ohio and being a centerline of said State Route 93, a distance of 102.85 feet to a point;

Course No. 8; Thence S $62^{\circ} 39^{\prime} 02^{\prime \prime}$ W, along a northwesterly line of said parcel conveyed to Countryside Chapel of Baltic, Ohio and being a centerline of said State Route 93, a distance of 88.79 feet to a point;

Course No. 9; Thence S $60^{\circ} 38^{\prime} 04^{\prime \prime}$ W, along a northwesterly line of said parcel conveyed to Countryside Chapel of Baltic, Ohio and being a centerline of said State Route 93, a distance of 117.27 feet to a point;

Course No. 10; Thence S $58^{\circ} 23^{\prime} 38^{\prime \prime}$ W, along a northwesterly line of said parcel conveyed to Countryside Chapel of Baltic, Ohio and being a centerline of said State Route 93, a distance of 119.25 feet to a point;

Course No. 11; Thence N $88^{\circ} 18^{\prime} 49^{\prime \prime}$ W, along said southerly line of the Northwest Quarter of Section 17, passing an iron pin set at a distance of 44.33 feet, a total distance of 158.37 feet to the True Place of Beginning and containing 2.693 acres of land, more or less, as surveyed by David J. Kroger, P.S., Ohio Registration No. S-8329, in February, 2022, but subject to all legal roads, highways, right of ways, easements and leases of record.

All iron pins set are 30 inch $\mathrm{X} 3 / 4$ inch round steel bars with plastic caps stamped "DIVERSIFIED ENGINEERING".
