Commencing at a 5/8 inch rebar found capped "Baker" marking the southeast corner of the southwest quarter of section 23, thence N 89 degrees 00'20"W a distance of 44.60 feet along Coshocton County line and the Section line to a stone found, thence N 88 degrees 25'30" W a distance of 1062.68 feet along the Coshocton County line and Section line to a 5/8 inch rebar found, thence N 00 degrees 43'50"E a distance of 14.27 feet along the west line of Marvin M. and Susan D. Mast (O.R. Vol. 186 Page 2263) to a point in the centerline of State Route 643, thence N 62 degrees 14'15"E a distance of 138.30 feet along the north line of said Marvin M. and Susan D. Mast and along the centerline of said road to a point, thence N 66 degrees 31'27"E a distance of 108.33 feet along the north line of said Marvin M. and Susan D. - 3. S 28 degrees 57'50" E a distance of 297.89 feet through the lands of said Mervin A. Hershberger and Katie R. Mast to an iron pin set;

- **4.** S **43 degrees 16'49"** E a **distance of 265.12 feet** through the lands of said Mervin A. Hershberger and Katie R. Mast to an iron pin set
- **5. S 08 degrees 37'11" E a distance of 264.68 feet** through the lands of said Mervin A. Hershberger and Katie R. Mast to the TRUE PLACE OF BEGINNING.
