## Description: 6.751 Acres

Being part of Lot 3 of the First Quarter, Hardy Township, T-9 N, R-7 W, Holmes County, Ohio, also known as part of the lands of Suzanne Gwen Gallion in O.R. Vol. 168 Page 888 and O.R. Vol. 168 Page 893 and Suzanne Gwen Hackaday in Deed Vol. 274 Page 5, (PPN 0600244000),(PPN 0600244006).

Further described as follows;

Commencing at a point marking the southeast corner of Lot 3, thence N 88 degrees 12'48" W a distance of 2670.05 feet along the Lot line to a 5/8 inch pin found capped "Baker", thence with a curve turning to the left with a delta angle of 0 degree 28'59", an arc length of 60.81 feet, with a radius of 7212.00 feet, with a chord bearing of N 11 degrees 08'49" E, with a chord length of 60.81 feet along the east line of The Board of Commissioners of the Holmes County Park District (O.R. Vol. 191 Page 1407) to an iron pin set being the TRUE PLACE OF BEGINNING.

Thence with the following SIX (6) COURSES;

- thence with a curve turning to the left with a delta angle of 4 degrees 58'02", an arc length of 625.26 feet, with a radius of 7212.00 feet, with a chord bearing of N 08 degrees 25'18" E, with a chord length of 625.06 feet, along the east line of said The Board of Commissioners of the Holmes County Park District to a 5/8 inch pin found capped "Diversified";
- 2. S 88 degrees 50'17" E a distance of 552.17 feet along the south line of Matthew Miller and Jason Chupp (O.R. Vol. 270 Page 2354) to a point in State Route 83 witnessed by a 5/8 inch pin found capped "Diversified" N 88 degrees 50'17" W a distance of 23.03 feet;



- **3.** S 06 degrees 22'45" W a distance of 401.55 feet along the west line of Thomas E. Ames (Deed Vol. 235 Page 116, Deed Vol. 279 Page 620, and O.R. Vol. 98 Page 46) and along the centerline of said road to a point;
- 4. N 88 degrees 12'48'' W a distance of 248.68 feet through the lands of said Suzanne Gwen Hackaday to an iron pin set passing over an iron pin set at a distance of 39.47 feet;
- 5. S 01 degree 35'25" W a distance of 226.64 feet through the lands of said Suzanne Gwen Hackaday and said Suzanne Gwen Gallion to an iron pin set;
- 6. N 88 degrees 12'48" W a distance of 344.31 feet through the lands of said Suzanne Gwen Gallion to THE TRUE PLACE OF BEGINNING.
