Being part of the Southwest Quarter of Section 21, Northeast Quarter Section 22, and the Southeast Quarter of Section 22, Hardy Township, T-9 N, R-7 W, Holmes County, Ohio, also known as the lands of Darrell W. Hood, Roberta Hood Myers, Karen L. Morello, and Robyn Harford, in O.R. Vol. 117 Page 338 and the lands of Dogwood Acres in O.R. Vol. 177 Page 2329, PPN 0600330000, PPN 0600331000, PPN 0601149000, and PPN 0600330002.

- 19. N 88 degrees 58'38" W a distance of 660.10 feet along the section line and along said Township lines to a stone found;
- 20. N 88 degrees 42'58" W a distance of 657.33 feet along the section line and along said Township lines to a 5/8 inch rebar found;
- 21. N 00 degrees 28'22" E a distance of 1343.44 feet passing into Section 22 and along the east line of Vivian Smith, Successor Trustee (O.R. vol. 247 Page 2267) to a 5/8 inch rebar found capped "Baker";
- **22.** N 01 degree 00'21" E a distance of 1329.83 feet along the east lines of Robert L. Whitman Sr. and Sharon K. Whitman (O.R. Vol. 116 Page 863) and Joseph I. Mast and Edna Mast (O.R. Vol. 186 Page 1475) to a 5/8 inch rebar found;
- **23.** N 01 degree 16'36" E a distance of 790.44 feet along the Village of Millersburg Corp. line to a point witnessed by a 5/8 inch rebar found N 01 degree 16'36" E a distance of 22.36 feet;
- **24.** S 69 degrees 18'50" E a distance of 1421.37 feet along the south lines of T & L Transport, Inc. (O.R. Vol. 122 Page 827) and LLWM Company Limited (O.R. Vol. 19 Page 234) to a point witnessed by an iron pin set S 01 degree 20'11" W a distance of 22.80 feet;
- **25.** S 01 degree 20'11" W a distance of 330.00 feet along the section line to the TRUE PLACE OF BEGINNING.

This parcel contains 154.351 acres and is subject to all highways, easements, and restrictions of record. Containing 55.578 acres in Section 21 and 98.773 acres in Section 22.

Also subject to a 50 foot easement recorded in Plat Vol. 19 Page 4075.
