Being part of the Southeast Quarter and Northeast Quarter of Section 12, Killbuck Township, T-8 N, R-8 W, Holmes County, Ohio, also known as part of the lands of Ronald W. Bevington and Patricia K. Bevington in O.R. Vol. 223 Page 857 (PPN 0800059000, PPN 0800058000).

Described as follows:
