## Described as follows:

Commencing at a 3/4 inch pipe found marking the southeast corner of the northwest quarter of section 14, thence N 88 degrees 38'40" W a distance of 675.32 feet along the quarter section line to a 3/4 inch pipe found, thence N 01 degrees 27'03" E a distance of 1233.96 feet along the west line of Allen R. Fox and Julia M. Fox (Deed Vol. 233 Page 82) to a point in the centerline of County Road 35 witnessed by a 3/4 inch pipe found N 01 degrees 27'03" E a distance of 37.71 feet being the TRUE PLACE OF BEGINNING;

Thence with the following SIX (6) COURSES;

- 1. S 77 degrees 57'06" W a distance of 39.70 feet through the lands of said Robert W. Fox and Sue Fox and along the centerline of said road to a point;
- 2. S 79 degrees 44'45" W a distance of 181.70 feet through the lands of said Robert W. Fox and Sue Fox and along the centerline of said road to a point;
- 3. S 81 degrees 44'54" W a distance of 167.59 feet through the lands of said Robert W. Fox and Sue Fox and along the centerline of said road to a point;
- 4. N 00 degrees 58'31" E a distance of 154.08 feet through the lands of said Robert W. Fox and Sue Fox to a 3/4 inch pipe found passing over an iron pin set at a distance of 20.00 feet;
- 5. N 77 degrees 48'36" E a distance of 394.12 feet along the south line of said Allen R. Fox and Julia M. Fox to a 3/4 inch pipe found;

6. S 01 degrees 27'03" W a distance of 172.65 feet along the west line of said Allen R. Fox and Julia M. Fox to the TRUE PLACE OF BEGINNING.
