Being part of Lot 19 of the First Quarter, Lot 44 of the Fourth Quarter and Fractional Section 13, T-9 N, R-9 W, Knox Township, Holmes County, Ohio, also being the lands of Joyce A. Balderston aka Joyce Balderston in Deed Vol. 176 page 251, Deed Vol. 165 Page 278, and O.R. Vol. 287 Page 3714, PPN 1100016000, PPN 1100017000, PPN 1100018000, PPN 1100019000.

Described as follows:

Commencing at a 5/8 inch rebar found marking the southeast corner of Lot 19 of the first quarter being the TRUE PLACE OF BEGINNING.

Thence with the following THIRTEEN (13) COURSES;

- 1. S 88 degrees 33'47" E a distance of 659.22 feet along the Lot line to a stone found;
- 2. S 01 degree 42'58" W a distance of 906.28 feet along the Lot line to a 5/8 inch rebar found;
- **3.** N 88 degrees 37'27" W a distance of 1094.86 feet passing into Fractional Section 13 and along the north line of Matthew O. Mallasch and Amanda L. Mallasch (O.R. Vol. 273 Page 3570) to a 5/8 inch rebar found;
- **4. S 00 degrees 09'44" E a distance of 906.67 feet** along the west line of said Matthew O. Mallasch and Amanda L. Mallasch to a point witnessed by a pipe found N 88 degrees 52'16" W a distance of 3.04 feet;
- **5.** N 88 degrees 52'16" W a distance of 2125.72 feet along the north lines of Toby D. Harris and Joanna M. Harris (O.R. Vol. 259 Page 6264) and Shawn M. Whitworth and Melissa N. Whitworth (O.R. Vol. 172 Page 2734) to a 5/8 inch rebar found;
- **6.** N 02 degrees 16'41" E a distance of 1328.74 feet along the Section line to point on the Lot line witnessed by a 5/8 inch rebar found S 02 degrees 16'41" W at a distance of 12.27 feet;
- 7. S 88 degrees 03'14" E a distance of 1557.11 feet along the Section line and Lot line to an iron pin set;
- 8. N 01 degree 18'42" E a distance of 510.43 feet along the Lot line to an iron pin set;
- 9. N 02 degrees 35'31" E a distance of 1216.23 feet along the Lot line to a 5/8 inch rebar found;

- **10.** N **01 degree 45'39"** E **a distance of 1531.55 feet** along the Lot line to a 5/8 inch rebar found capped "Baker";
- 11. S 87 degrees 43'52" E a distance of 964.88 feet along the south line of Kenneth C. Norris, Jr. and Jill A. Norris (O.R. Vol. 197 Page 4) to a 5/8 inch rebar found witnessed by a 5/8 inch rebar found capped "Baker" N 87 degrees 43'52" W at a distance of 31.00 feet;
- **12. S 01 degree 51'19" W a distance of 1085.97 feet** along the Lot line and along the centerline of T.R. 213 to a 5/8 inch rebar found;
- **13.** S **02** degrees **18'25"** W a distance of **1647.75** feet along the Lot line to the TRUE PLACE OF BEGINNING;
