- 8) N 02 degrees 00' 20" E 1396.35 feet along the lot line and along T.R. 213 to the TRUE POINT OF BEGINNING.


This parcel contains 61.501 acres, but subject to all highways and easements of record. Containing 10.216 acres in Lot 17 and 51.285 acres in Lot 18.
