## 8.286 Acre Description

Being part of the Fourth Quarter Lot 2 and Lot 3, Knox Township, T-9N; R-9W, Holmes County, Ohio, also known as part of the lands conveyed to Daniel L. Stutzman and Mary Stutzman in O.R. Vol. 265 Page 5942 (PPN 1100118000 and PPN 1100121000).

## Further described as follows:

Beginning at a 3/4 inch pipe found marking the northeast corner of Lot 3, thence S 00 degrees 32'58"W a distance of 651.74 feet along the Lot Line and the line between Knox Township and Monroe Township to a 5/8 inch rebar found capped "Baker", thence S 00 degrees 34'45" W a distance of 364.75 feet along said lot line and township line to a 3/4 inch pipe found, thence N 85 degrees 21'22" W a distance of 333.53 feet along the south line of Sharon E. Robinson-Armstrong, trustee (O.R. Vol. 238 Page 2392) to an iron pin set the TRUE PLACE OF BEGINNING.

## Thence with the following SIX (6) COURSES:

- 1. S 23 degrees 18'37" W a distance of 615.44 feet through the lands of said Daniel L. Stutzman and Mary Stutzman to an iron pin set;
- 2. N 49 degrees 27'12" W a distance of 210.68 feet through the lands of said Daniel L. Stutzman and Mary Stutzman to an iron pin set;
- 3. N 63 degrees 47'02" W a distance of 289.52 feet through the lands of said Daniel L. Stutzman and Mary Stutzman to an iron pin set;
- 4. N 55 degrees 16'07" W a distance of 589.07 feet through the lands of said Daniel L. Stutzman and Mary Stutzman to a point in Township Road 221 witnessed by an iron pin set S 55 degrees 16'07"E a distance of 25.45 feet;

- 5. N 11 degrees 03'25" W a distance of 60.00 feet along said road and the east line of Norman Troyer (Deed Vol. 278 Page 874) to a 5/8 inch rebar found;
- 6. S 85 degrees21'22" E a distance of 1162.80 feet along the south line of said Sharon E. Robinson-Armstrong, trustee passing through an iron pin set at a distance of 35.63 feet to the TRUE PLACE OF BEGINNING.
