11) N 11 degrees $23^{\prime} 53^{\prime \prime} \mathrm{W} 223.23$ feet along the centerline of S.R. 83 to a point, witnessed by a $5 / 8$ inch rebar found N 77 degrees $21^{\prime} 25^{\prime \prime}$ E 26.25 feet;
12) N 77 degrees $21^{\prime} 25^{\prime \prime} E 486.36$ feet along Matthew D. Morris' (O.R. 229 page 2671) south line to a $5 / 8$ inch rebar found;
13) N 04 degrees $38^{\prime} 38^{\prime \prime} \mathrm{W} 367.18$ feet along said Morris' east line to a $5 / 8$ inch rebar found;
14) S 89 degrees 23' 57" E 629.11 feet along Dan G. Troyer, Verna H. Troyer and Aaron D. Troyer's (O.R. 251 page 579) south line to a $5 / 8$ inch rebar found on the section line;
15) N 01 degrees $40^{\prime} 57^{\prime \prime}$ E 333.96 feet along the section line to the TRUE POINT OF BEGINNING.
