Being part of the Second Quarter, Lot 16 and Lot 25, T-9 N, R-8 W, Southwest Quarter of Section 21, T-17 N, R-14 W, Monroe Township, Holmes County, Ohio, also known as the lands of Blair A. Bower and Christine E. Bower in O.R. Vol. 247 Page 5361, PPN 1400038000.

Described as follows:

Commencing at a railroad spike found marking the northeast corner of Lot 17 in the centerline of T.R. 257 witnessed by a 5/8 inch rebar found capped "Galbraith" S 87 degrees 47'16" E a distance of 16.27 feet being the TRUE PLACE OF BEGINNING.

- 2. N 03 degrees 10'46" E a distance of 1391.52 feet crossing into the southwest quarter of section 21 and along the east line of Adam P. Campbell and Linda S. Campbell (O.R. Vol. 279 Page 3231) to a point in S.R. 39 & 60 witnessed by a 5/8 inch rebar found S 03 degrees 10'46" W at a distance of 77.65 feet;
- 3. S 69 degrees 30'03" E a distance of 158.55 feet along the south line of Robert D. Hershberger and Clara Hershberger (O.R. Vol. 263 Page 2663) and along the centerline of said road to a point on the lot line;
- **4. S 60 degrees 32'36" E a distance of 598.01 feet** passing through Lot 25 and into Lot 16 and along the south line of Owens Fortune, LLC (O.R. Vol. 270 Page 3107), and Karen J. Bright (O.R. Vol. 189 Page 3015), and Thomas W. Bright and Tara J. Bright (O.R. Vol. 255 Page 2845), and Regan and Darla Miller (O.R. Vol. 274 Page 3232), and along the centerline of said road to a point;
- 5. S 59 degrees 34'29" E a distance of 443.83 feet along the south line of Regan Miller and Darla Miller (O.R. Vol. 184 Page 3398) and along the centerline of said road to a point;
- **6. S 60 degrees 20'24" E a distance of 102.78 feet** along the south line of said Regan Miller and Darla Miller and along the centerline of said road to a point;
- 7. S 61 degrees 57'13" E a distance of 99.26 along the south line of said Regan Miller and Darla Miller and along the centerline of said road to a point;
- 8. S 63 degrees 48'20" E a distance of 99.52 feet along the south line of said Regan Miller and Darla Miller and along the centerline of said road to a point;

- 13. S 01 degree 38'42" W a distance of 260.02 feet along the west line of John Dean Slates and Carol Ann Slates (O.R. Vol. 208 Page 314) to a 5/8 inch rebar found capped "Galbraith" passing over an 5/8 inch rebar found capped "Galbraith" at a distance of 42.35 feet;
- **14.** N 87 degrees 47'16" W a distance of 1327.65 feet along the Lot Line to the TRUE PLACE OF BEGINNING.
