Being part of the Fourth Quarter of Lot 30, Paint Township, T-10 N, R-5 W, Holmes County, Ohio, also known as part of the lands of Ivan C. Miller and Naomi Miller (O.R. Vol. 261 Page 5104) PPN 1500301000.

Described as follows:

Commencing at a 5/8 inch rebar found on the Walnut Creek Township line and marking the southwest corner of Lot 30, thence N 01 degree 18'23" E a distance of 297.00 feet along the Lot line and along the centerline of T.R. 423 to a point, thence S 88 degrees 34'01" E a distance of 401.78 feet along the north line and south line of Paul P. Miller, Jr. and Freida Miller (O.R. Vol. 241 Page 2957) to a 5/8 inch rebar found being the TRUE PLACE OF BEGINNING.

Thence with the following SEVEN (7) COURSES;

- 1. N 31 degrees 00'19" W a distance of 422.51 feet along the east line of David Lee Miller and Sandra Miller (O.R. Vol. 231 Page 3200) to a point in S.R. 62 witnessed by a 5/8 inch rebar found S 31 degrees 00'19" E at a distance of 31.72 feet;
- 2. N 39 degrees 16'40" E a distance of 106.23 feet along the centerline of said road and along the south line of said Paul P. Miller, Jr. and Freida Miller to a point witnessed by an iron pin set S 48 degrees 38'37" E at a distance of 30.00 feet;
- **3. S 48 degrees 38'37'' E a distance of 376.40 feet** through the lands of said Ivan C. Miller and Naomi Miller to an iron pin set;
- 4. N 72 degrees 06'40'' E a distance of 257.11 feet through the lands of said Ivan C. Miller and Naomi Miller to an iron pin set;



- 5. S 34 degrees 28'04'' E a distance of 143.04 feet through the lands of said Ivan C. Miller and Naomi Miller to an iron pin set;
- 6. S 39 degrees 34'52" W a distance of 213.77 feet through the lands of said Ivan C. Miller and Naomi Miller to an iron pin set;
- 7. N 88 degrees 34'01" W a distance of 321.66 feet along the north line of said Paul P. Miller, Jr. and Freida Miller to the TRUE PLACE OF BEGINNING.
