19) $N 05$ degrees $00^{\prime} 00^{\prime \prime} \mathrm{E} 471.95$ feet along said Yoder's east line to a $5 / 8$ inch rebar found on the quarter section line;
20) S 85 degrees $05^{\prime} 20^{\prime \prime}$ E 346.50 feet along the quarter section line to the TRUE POINT OF BEGINNING.
