- 12. S 00 degrees 13'31" E a distance of 970.20 feet along the section line and along the centerline of said road to a railroad spike found marking the southeast corner of the northeast quarter of section 35;
- **13.** S **89** degrees **38'41"** W a distance of **2705.13** feet along the quarter section line and along the centerline of Township Road 606 to THE TRUE PLACE OF BEGINNING.
