Vol. 172 Page 2391 (PPN 2400493002) and part of the lands of Aden B. Weaver and Emma B. Weaver in Deed Vol. 230 Page 597 (PPN 2400493000).

Described as follows:

Commencing at a 5/8 inch rebar found marking the northeast corner of the northwest quarter of section 35, thence S 89 degrees 33'00"W a distance of 330.00 feet along the section line and the centerline of Township Road 613 to a railroad spike found witnessed by a 5/8 inch rebar found capped "Baker" S 00 degrees 00'25" E a distance of 19.34 feet being the TRUE PLACE OF BEGINNING.

- 3. S 74 degrees32'39" W a distance of 12.16 feet through the lands of said Aden B. Weaver and Emma B. Weaver to an iron pin set;
- 4. N 00 degrees52'50" E a distance of 201.74 feet through the lands of said Aden B. Weaver and Emma B. Weaver and said Abe D. Hershberger and Clara Hershberger to an iron pin set;
- 5. N 76 degrees 48'14" E a distance of 489.77 feet along the south line of said Aden B. Weaver and Emma B. Weaver to an iron pin set;

- 6. N 00 degrees00'25" W a distance of 635.31 feet along the east line of said Aden B. Weaver and Emma B. Weaver toa 5/8 inch rebar found capped "Baker";
- 7. S 89 degrees 33'00" W a distance of 220.11 feet along the north line of said Aden B. Weaver and Emma B. Weaver to a 5/8 inch rebar found capped "Baker";
- 8. N 00 degrees27'14" W a distance of 50.00 feet along the east line of said Aden B. Weaver and Emma B. Weaver to a point on the section line and in said road witnessed by a 5/8 inch reber found capped "Baker" S 00 degrees27'14" E a distance of 14.88 feet;
- 9. N 89 degrees33'00" E a distance of 270.50 feet along the section line and said road to the TRUE PLACE OF BEGINNING.
