- S 87 degrees 45' 01" E 194.16 feet through the lands of said Spreng to an iron pin set;
- 3) S 70 degrees 54' 12" E 172.83 feet through the lands of said Spreng to a point in the center of T.R. 465, witnessed by an iron pin set N 70 degrees 54' 12" W 51.39 feet;
- S 87 degrees 08' 42" E 464.60 feet along the centerline of T.R. 465 to an iron pin set;
- 5) S 88 degrees 28' 56" E 392.81 feet along the centerline of T.R. 465 to an iron pin set;
- S 86 degrees 11' 27" E 102.74 feet along the centerline of T.R. 465 to a 5/8 inch rebar found;
- S 85 degrees 46' 32" E 152.39 feet along the centerline of T.R. 465 to a 5/8 inch rebar found;
- N 80 degrees 20' 28" E 437.31 feet along the centerline of T.R. 465 to a 5/8 inch rebar found;
- 9) S 82 degrees 07' 25" E 114.33 feet along the centerline of T.R. 465 to a R.R. spike found at the intersection of T.R. 465 and T.R. 466;
- 10) S 34 degrees 09' 22" W 859.73 feet along Marvin F. Edwards and Betsy A. Edwards' (O.R. 186 page 2519) west line and along T.R. 466 to a point on the quarter section line, witnessed by an iron pin set N 87 degrees 31' 21" W 6.35 feet;
- 11) N 87 degrees 31' 21" W 1688.82 feet along the quarter section line to the TRUE POINT OF BEGINNING.




This parcel contains 28.393 acres, but subject to all highways and easements of record.
