Being part of the Northwest Quarter of Section 5, Clark Township, T-8 N, R-5 W, Holmes County, Ohio, also known as part of the lands conveyed to John S. and Esther M. Miller in Deed Vol. 236 page 574 (PPN 3300134000).

Commencing at 5/8 inch rebar found capped "Baker" marking northwest corner of the northwest quarter of section 5, thence N 88 degrees 36'26" E a distance of 401.56 feet along the Berlin Township and Clark Township lines to an iron pin set being the TRUE PLACE OF BEGINNING;
