## Description: 13.138 Acres

Being part of the Northwest Quarter of Section 5, Clark Township, T-8 N, R-5 W, Holmes County, Ohio, also known as part of the lands conveyed to John S. and Esther M. Miller in Deed Vol. 236 page 574 (PPN 3300134000).

Described as follows:

Commencing at a Mag Nail Found marking southwest corner of the northwest quarter of section 5, thence N00 degrees 33' 37" E a distance of 85.57 feet along the Mechanic Township line and Clark Township line to a Mag Nail set witnessed by a 5/8 inch rebar found S 79 degrees 06'06" E a distance of 8.00 feet being the TRUE PLACE OF BEGINNING;

Thence with the following TWENTY (20) COURSES;

- 1. N 00 degrees 33'37" E a distance of 1480.35 feet along the Mechanic Township and Clark Township lines to a point in the centerline of State Route 557 passing over a mag nail set at a distance of 773.15 feet and witnessed by an iron pin set S 00 degrees 33'37" W a distance of 70.61 feet;
- 2. S 10 degrees 17'18" E a distance of 47.93 feet along the south line of Alan M. Yoder and Lena Yoder (O.R.Vol. 169 Page 2084, O.R. Vol. 182 Page 1288) and along the centerline of said road to a point;

- 11. S 59 degrees 53'41" E a distance of 134.63 feet along the south line of said Jeffrey R. Barkman and Cheryl Ann Barkman to a point witnessed by an iron pin set N 39 degrees 25'51"E a distance of 18.00 feet;
- 12. S 60 degrees 46'36" E a distance of 49.88 feet through the lands of said John S. and Esther M. Miller and along the centerline of said road to a point;
- 13. S 14 degrees 34'26'' W a distance of 282.32 feet along the west lines of Paul D. Shetler, co-trustee and Mary Ann Shetler, co-trustee (O.R. Vol. 255 Page 1278) to a 5/8 inch rebar found capped "RLK" passing over an iron pin set at a distance of 22.67 feet;
- 14. S 48 degrees 01'26'' W a distance of 83.27 feet along the west line of said Paul D. Shetler, co-trustee and Mary Ann Shetler, co-trustee to a 5/8 inch rebar found against a fence post;
- 15. S 28 degrees 13'03'' W a distance of 137.09 feet along the west line of said Paul D. Shetler, co-trustee and Mary Ann Shetler, co-trustee and Kenneth D. Keim and Rosanna Marie Keim (O.R. Vol. 238 Page 2377) to a 5/8 inch rebar found capped "RLK";



- 16. S 54 degrees 26'43" W a distance of 95.83 feet along the west line of said Kenneth D. Keim and Rosanna Marie Keim to a 5/8 inch rebar found capped "RLK";
- 17. S 35 degrees 04'59" E a distance of 74.45 feet along the west line of said Kenneth D. Keim and Rosanna Marie Keim to a 5/8 inch rebar found capped "RLK";
- **18.** S 28 degrees 21'22'' W a distance of 168.59 feet along the west line of said Kenneth D. Keim and Rosanna Marie Keim to a 5/8 inch rebar found;
- **19.** N **79 degrees 08'34'' W a distance of 115.16 feet** along the north line of Alan Yoder and Lena Yoder (O.R. Vol. 249 Page 4165) to a 1/2 inch pipe found;
- **20.** N **79** degrees **06'06''** W a distance of **275.76** feet along the north line of Larry D. and Eugene E. Schlabach (Deed Vol. 251 Page 452) to the TRUE PLACE OF BEGINNING.
