Hershberger and Sandra A. Hershberger (Deed Vol. 246 Page 42) to a point, thence S 00 degrees 39'53" E a distance of 57.56 feet along the centerline of said road and along the east line of said Keith L. Hershberger and Sandra A. Hershberger to a point witnessed by a 5/8 inch rebar found N 80 degrees 21'35" E at a distance of 16.88 feet being the TRUE PLACE OF BEGINNING;

- 1. N 80 degrees 21'35" E a distance of 148.20 feet along the south line of Lot 1 of Kline Acres Subdivision (Plat Vol. 19 Page 711) of Jomar Group, Ltd. (O.R. Vol. 256 Page 2977) to a 5/8 inch rebar found capped "Baker";
- 2. S 00 degrees 27'28" W a distance of 214.18 feet along the west line of said Lot 1 of Kline Acres Subdivision of Jomar Group Ltd. to an iron pin set passing over a 5/8 inch rebar found capped "Baker" at a distance of 160.00 feet;
- 3. N 89 degrees 32'45" W a distance of 166.67 feet through the lands of said Zackary J. Miller and Rachel E. Miller to a point witnessed by an iron pin set S 89 degrees 32'45" E at a distance of 26.06 feet;
- **4.** N 12 degrees 41'19" E a distance of 55.45 feet along the centerline of said road and along the east line of said Keith L. Hershberger and Sandra A. Hershberger to a railroad spike found witnessed by a 5/8 inch rebar found capped "Baker" S 89 degrees 32'34" E at a distance of 25.90 feet;
- **5.** N 12 degrees 41'19" E a distance of 3.18 feet along the centerline of said road and along the east line of said Keith L. Hershberger and Sandra A. Hershberger to a point;
- **6.** N **06** degrees **15'12"** E a distance of **90.56** feet along the centerline of said road and along the east line of said Keith L. Hershberger and Sandra A. Hershberger to a point;

7. N 00 degrees 39'53" W a distance of 40.82 feet along the centerline of said road and along the east line of said Keith L. Hershberger and Sandra A. Hershberger to the TRUE PLACE OF BEGINNING.
