

**Description – Lot 2**

Being Lot 2 of Salt Creek Township Subdivision No. 20 recorded in Plat Book 19  
Page 5846, of the Holmes County Plat Records.

Lot 2 contains 3.481 acres, but is subject to all highways and easements of record.

Salt Creek Township Subdivision No. 20 is situated in the northwest quarter of Section 2, T-14 N, R-12 W, Salt Creek Township, Holmes County, Ohio.

Note: Lot 2 is subject to all Restrictive Covenants listed or shown on said Subdivision Plat.

Note: Lot 2 has access by a 50 foot common access easement for the purpose of ingress, egress, and general utilities, and further described as follows:

Being part of the northwest quarter of Section 2, T-14 N, R-12 W, Salt Creek Township, Holmes County, Ohio, also known as part of the lands conveyed to Susan J. Kauffman in Official Record vol. 268 page 2014, PN 3400666004.

Commencing at a R.R. spike found in T.R. 616 marking the southeast corner of the northwest quarter of Section 2, thence N 00 degrees 00' 26" W 1208.76 feet along the quarter section line to a 5/8 inch rebar found, thence S 89 degrees 08' 42" W 701.90 feet along Raymond L. Yoder and Laura A. Yoder's (O.R. 268 page 2301) north line to a 5/8 inch rebar found, thence S 87 degrees 24' 33" W 266.43 feet along said Yoder's north line to a point in T.R. 615 and on Merlin W. Keim and Eva Keim's (O.R. 258 page 2258) east line, thence N 00 degrees 00' 27" W 25.03 feet along T.R. 615 and along said Keim's east line to a point the TRUE POINT OF BEGINNING.

thence with the following THREE (3) COURSES along the centerline of a 50 foot common access easement:

- 1) N 87 degrees 24' 33" E 241.31 feet through the lands of said Kauffman to a point;
- 2) N 00 degrees 14' 40" W 123.64 feet through the lands of said Kauffman to a point;
- 3) N 89 degrees 08' 42" E 272.47 feet through the lands of said Kauffman to a point on the west line of the above described Lot 2 and THERE ENDS.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker Surveying LLC".
