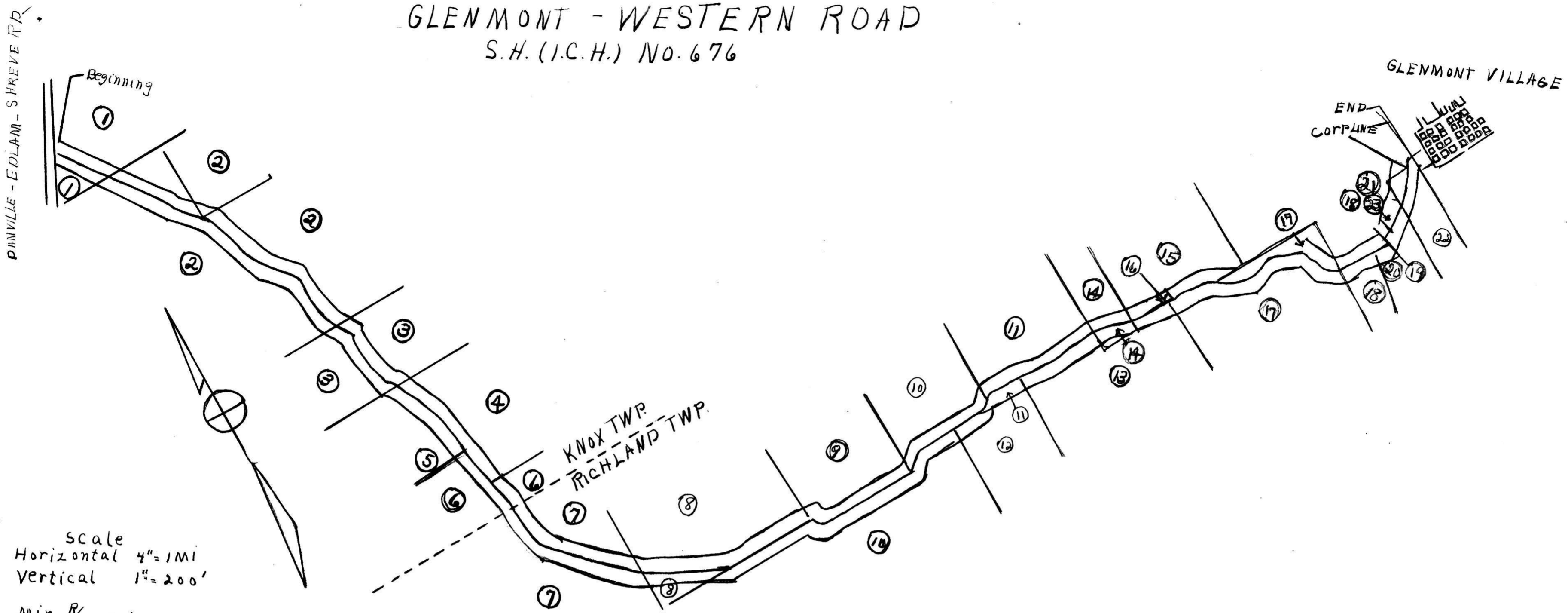


HOLMES COUNTY
