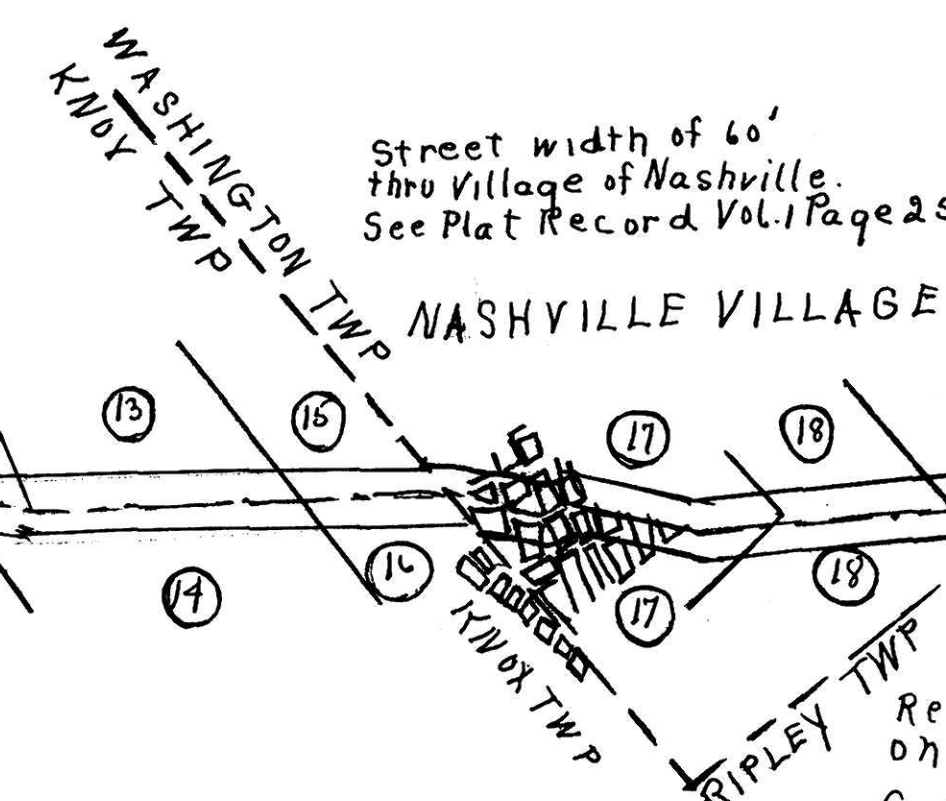
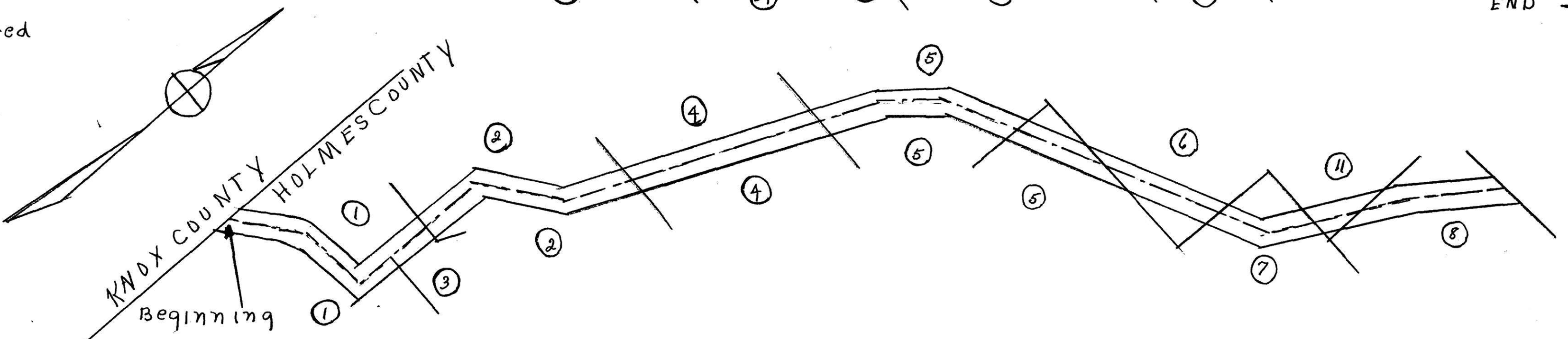


HOLMES COUNTY
