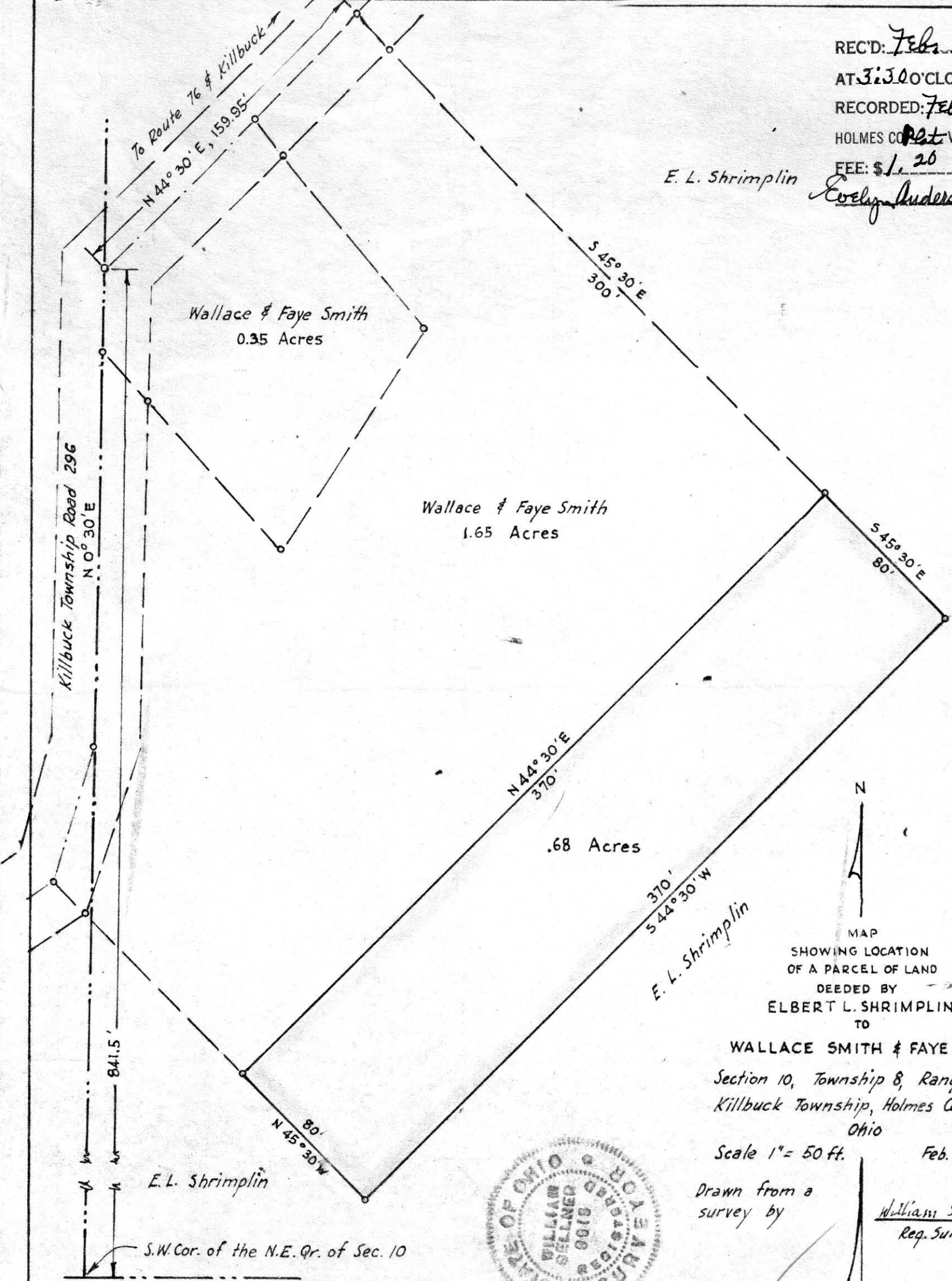

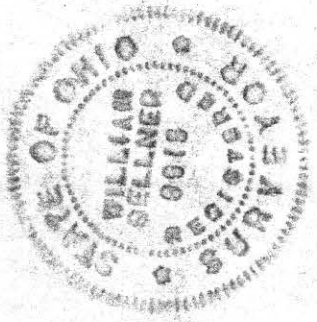

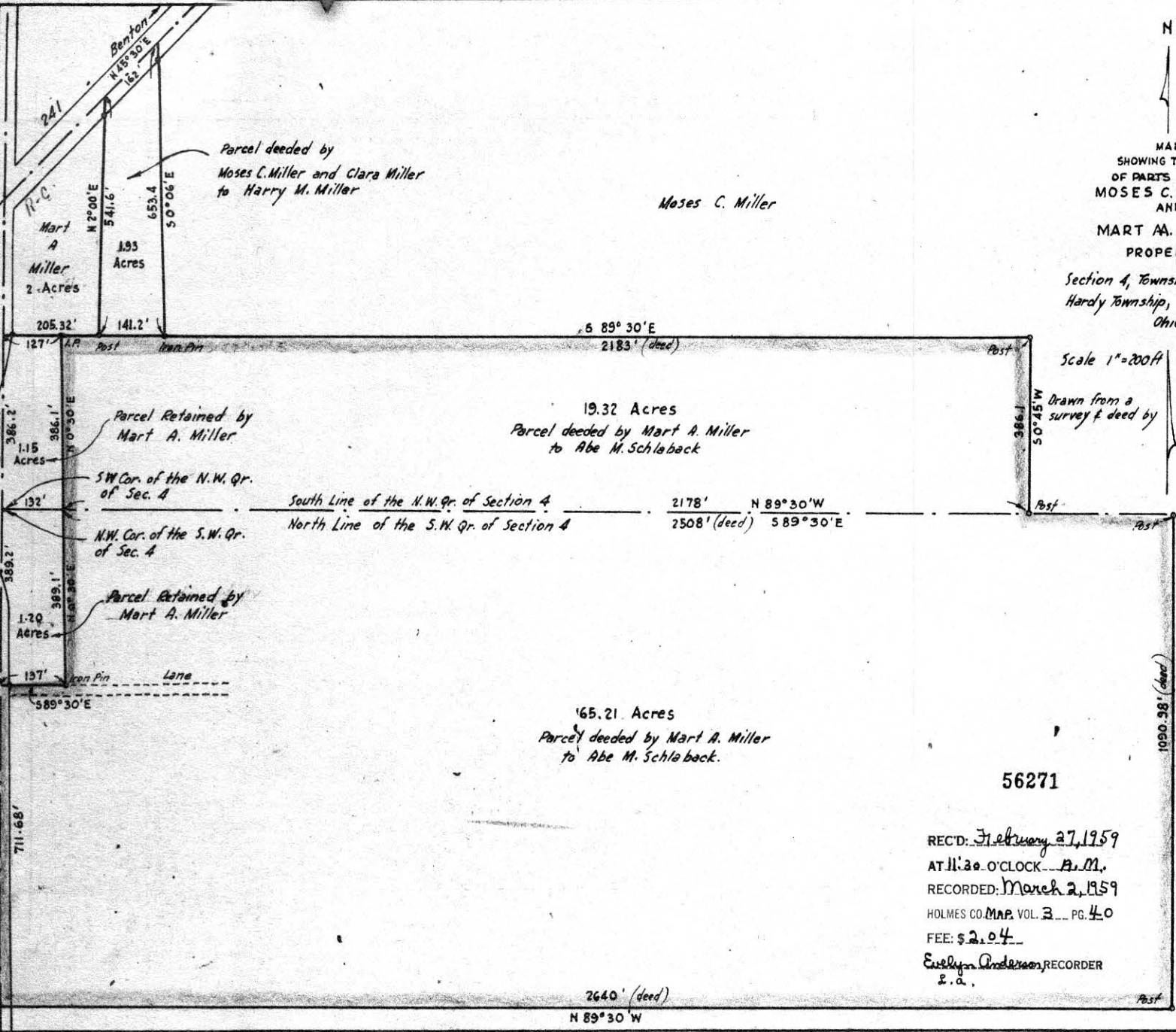
MAP

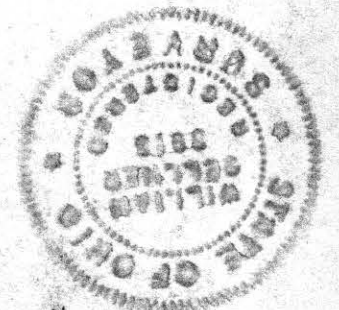
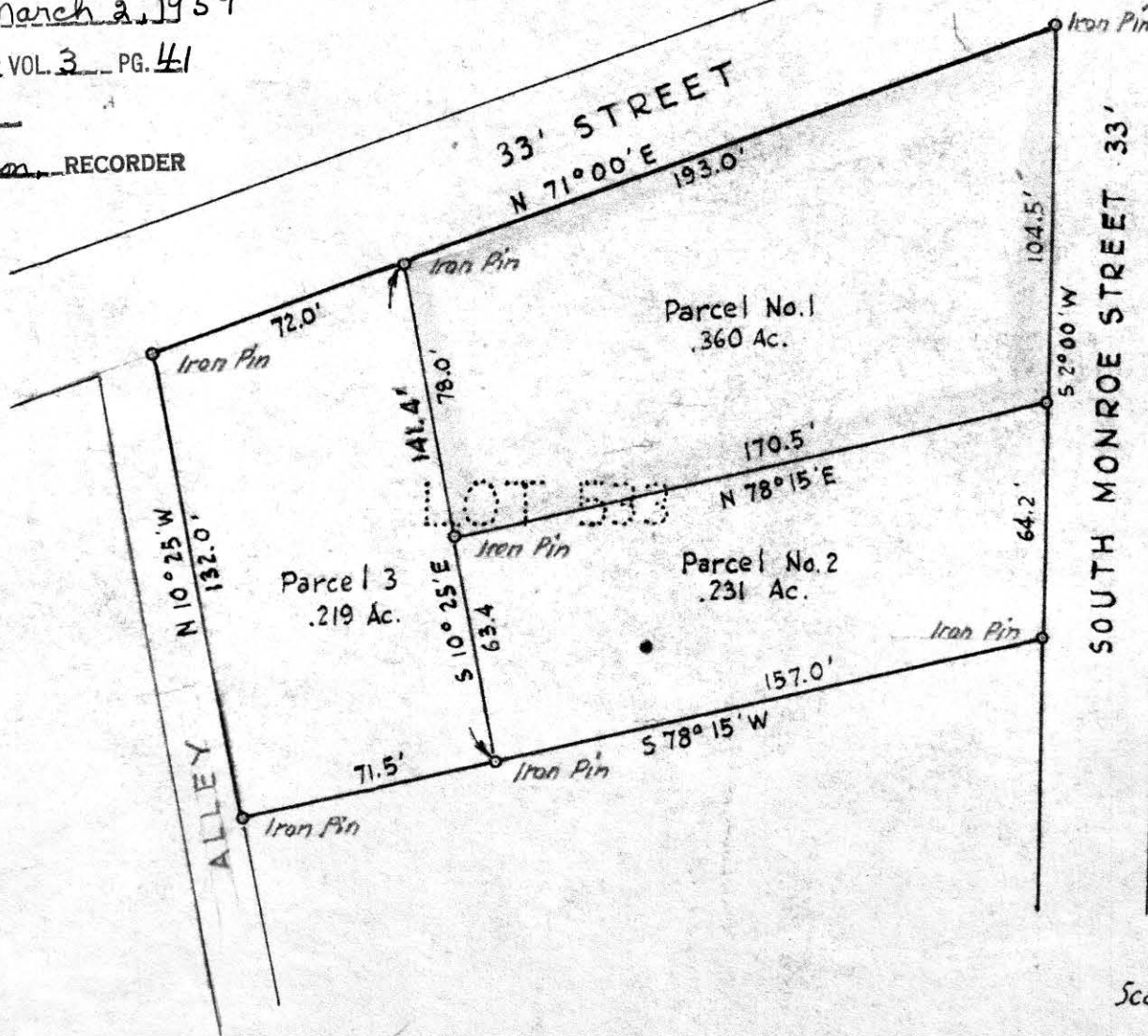
